SEPTEMBER BOARD MEETING



SUPERINTENDENT'S REPORT

(Date of report to WG Board was August 19, 2025)
It appears these mid-summer windstorms are becoming a regular occurrence. Again, we appreciate all the help with clean-up and do our best to make it around campus in a timely manner. This last one was different, as it was followed by approximately 2" of rain, causing the grass to take off again. We spent the first three days doing nothing but clean-up, but also had to catch back up on mowing. This required half of the crew to continue with pick up, while the other half jumped back on mowers.

Our larger mower broke down at the end of July and we waited 3 weeks for parts. We are also down 2 summer employees as they have returned to school and still have 1 part time summer employee until the end of August. We will do our best to get caught up on mowing and line trimming. We will also be spraying for weeds in the courtyards and commons through the end of August as temperatures and weather permit.

2025-26 Dues Increase Budgeting: Needs vs. Wants

The WG Board has been very careful over the last three years with -0- dues increase. Over the same time, inflation has increased almost 16% creating unmet needs. We have purchased -0-equipment in four years and our water bills are now around 142k a year.

Needs:

- Our campus has many 50-year-old trees that are in need of trimming or removal, some becoming a safety issue. In the recent July storm, we had 17 large trees down at an unbudgeted cost of \$25,720 using 3 different tree services.
- Water Line breaks are becoming more frequent and are very expensive to repair.
- We need to replace the old red truck, used daily for grounds maintenance and snow removal.
- Used Mower, a new one can cost 80k, we are looking at a used mower for 25k.
- Concrete In March we will have the concrete loan paid off. The last three years we have been building the Reserve enabling us to do \$100 - \$150k of concrete work this Fall. There is still deferred concrete work that needs to be done.

The checking account is below 50k. We have used the 50k CD for operations this year. The Board has voted to increase dues by \$25 to \$210 a month effective October 1, 2025. A copy of the budget is posted on our website at https://wellingtongreens.net/association/financial-info.html
